THE CONFERENCE

The theme for this year's conference is **Defects, Quality and Workmanship – Presenting the Evidence**.

Defective work and poor workmanship are problems which have been around for a long time. In Hong Kong, high profile cases include the short piling cases almost 20 years ago, and more recently a collapsing sports centre roof, lead in water pipes, controversy over wave absorbing blocks on the Hong Kong-Zhuhai-Macau Bridge and alleged defective works on the MTR Shatin to Central Link. Conversely, employers are frequently withholding money based on little evidence, often with liability between design and workmanship far from being established. This conference will examine typical standard provisions which deal with defective work, quality and workmanship, why such provisions do not always achieve their aims, and how evidence in such cases should be recorded and subsequently presented to a tribunal.

Keynote Address – The Honourable Rimsky Yuen, GBM, SC, JP

Morning Session 1 Defects and Workmanship

A review and discussion of the issues which commonly arise including general contractual provisions to deal with defective work, including what is a defect, remedies for non-conformity; common failures and whether such provisions achieve their objectives in HK, e.g. disputes on liability (design issues), common standards, interpretation of specifications, cash flow issues, poor supervision, unrealistic programmes, multi-layered subcontracting; how to manage serious defects in a project, e.g. potential structural failures or fraudulent work, mitigation of loss and when to engage other contractors to rectify defects.

Morning Session 2 Documentary Evidence

A review and discussion of issues including use of technology in construction projects (BIM, AI, Drones, WhatsApp / WeChat, email, Big data), legal implications and admissibility of such evidence; how does technology alter the presentation of evidence; keeping of records / evidence in relation to defects and progress; how to reduce volume of documentary evidence in construction disputes.

Panellists include **Mr Richard Coplin**, Keating Chambers; **Mr Paul Morris**, Head of Innovation, Gammon Construction; **Mr Francois Bolduc**, Integrated Design; and **Mr Glenn Haley**, Bryan Cave Leighton Paisner.

Afternoon Session 3 Factual Witnesses / Evidence

A review and discussion of issues including a QC's perspective on factual evidence and factual witnesses, witness' perspectives, dos and don'ts, presentation of factual evidence in ADR (mediation / expert determination / adjudication), and differences between litigation/arbitration and different forms of ADRs, preservation of factual evidence for defects expert, and interviewing and taking factual witness statements.

Afternoon Session 4 Expert Witnesses / Evidence

A review and discussion of issues including a QC's perspective on expert evidence and expert witnesses, judge/arbitrator's perspective on expert evidence and expert witnesses; expert's perspectives; dos and don'ts, instructing and managing experts, single joint experts, hot tubbing, and use/necessity of experts / expert evidence in ADR.
