### About this Conference

The international construction industry has been plagued by the issue of long-drawn-out and costly construction disputes which drain parties' resources while also tying up cashflow.

It can be said that for this reason alone many jurisdictions across the world have turned towards statutory and/or contractual adjudication processes aimed at providing an expeditious resolution to cashflow-related disputes which arise during the project life cycle.

In countries which have enacted legislation for statutory adjudication, the statutory process has become the primary means of resolution of disputes for domestic construction projects, especially in the realm of payment disputes. Per Coulson LJ in *John Doyle Construction Ltd (In Liquidation) v Erith Contractors Ltd (2021)* - "It is not an alternative to anything; for most construction disputes, it is the only game in town."

Alongside statutory adjudication, there has been an increasing shift towards the use of contractual dispute avoidance regimes alongside collaborative contracting forms designed to avoid or minimise the occurrence of disputes altogether.

In this Conference, the International Statutory Adjudication Forum (ISAF) will unveil its proposed Model Law On Statutory Adjudication, which draws upon the experiences of international practitioners from across the globe. The intention of the Model

Law on Statutory Adjudication is to provide states who are considering the enactment of a statutory adjudication regime with a draft law which embodies best current practice which may be either adopted or adjusted to suit local conditions. The speakers will also share their experiences on collaborative contracting forms and processes, and their reflections on their efficacy in the avoidance and resolution of disputes in the construction industry.

The Conference will be officially opened by **Mr. Chow Kok Fong, Chairman of the ISAF**. We are privileged to have **Justice Philip Jeyaretnam - President of the Singapore International Commercial Court and Judge of the High Court** grace our Conference as our Guest of Honour and deliver the Keynote Address.

The Conference will also host some of the foremost construction law practitioners and industry experts to provide delegates a series of four sessions which focus on:

**Mr. Chow Kok Fong**  
Chartered Arbitrator; Chairman,  
International Statutory Adjudication Forum

Chow Kok Fong is Chairman of the International Statutory Adjudication Forum. He is a Chartered Arbitrator and currently practises as a mediator, arbitrator and adjudicator. In his earlier career he

was CEO of Changi Airports International and of the Construction Industry Development Board and has held many other senior appointments with several large real estate and construction companies. He is Founder President of the Society of Project Managers, past Chairman of the Society of Construction Law and currently, chairs the Construction Adjudicators Accreditation Committee.

Among his 20 books are the two-volume work *Law and Practice of Construction Contracts* (now in its 5<sup>th</sup> edition 2018); *Security of Payments and Construction Adjudication* (now in its 3<sup>rd</sup> edition 2022), *Construction Contracts Dictionary* (now in its 2<sup>nd</sup> edition 2014) and the Building and Construction Law Volume in *Halsbury's Laws of Singapore* (2019 and 2023 editions). A new book, *Construction Arbitration*, is due for release in the 3<sup>rd</sup> quarter of 2023. On 1 November 2013, he was awarded the quinquennial Singapore Academy of Law Award 2013 for contributions in promoting and advancing the development of Singapore law. In 2018, he was conferred a Singapore National Day Award for services to the Singapore Academy of Law. In November 2022, he was elected Fellow of the International Academy of Construction Lawyers.



**Ms. Karen Gough**

Karen Gough is a Barrister in practice at 39 Essex Chambers, London, an Attorney-at-law (Jamaica and Trinidad and Tobago), Arbitrator and accredited Adjudicator. Karen practises internationally as counsel, attorney-at-law, arbitrator, adjudicator and ADR neutral. She has specialised, for more

**Justice Mary Lim Thiam Suan**  
Federal Court Judge of Malaysia

Justice Mary Lim Thiam Suan read law at the University of Leeds, UK and graduated with LLB (Hons). She was admitted to Lincoln's Inn as a Barrister-at-law. She also obtained her Master of Laws degree from the University of Western Australia. Prior to her elevation to the High Court of

Malaya where she had sat in her new Commercial Court, her Ladyship served in various capacities at the Attorney General's Chambers of Malaysia. These include as Senior Federal Counsel, Senior Assistant Parliamentary Draftsman, Legal Advisor to the State of Negeri Sembilan, Deputy Head of Civil Division and Commissioner of Law Revision and Law Reform.

Justice Lim was the first judge of the Construction Court in Kuala Lumpur until her Ladyship's elevation to the Court of Appeal. Her Ladyship is now a Judge of the Federal Court of Malaysia. Justice Lim is a qualified advocacy trainer with the Bar Council Malaysia and has conducted numerous courses on the subject including the Advanced Advocacy Course at Keble College, Oxford. She has also delivered many public lectures of various topics associated with the law both nationally and internationally.
