## ABOUT THE KEYNOTE SPEAKER

### The Honourable Mr Justice **RAMSEY**, United Kingdom

Sir Vivian Ramsey studied Engineering Science and Economics at Oxford University before working as a civil engineer in the UK and overseas. During this time he became a Chartered Engineer and a Member of the Institution of Civil Engineers.

After studying law he was called to the Bar in 1979 and was a practising barrister in Keating Chambers and from 2003 to 2005 Head of Chambers. He became a Queen's Counsel in 1992 and practised around the world as an advocate, arbitrator, adjudicator and mediator. He appeared in English and overseas courts and was called to the Bar in Hong Kong, Singapore, Brunei and Trinidad for particular cases in those jurisdictions. He acted as counsel in numerous arbitrations and was appointed as chairman, co-arbitrator or sole arbitrator in some 90 arbitrations including ICC, LCIA, UNCITRAL, SCC, JCCA and other institutional or ad-hoc arbitrations. He was also appointed as a mediator and an adjudicator as well as being an expert appointed by the ICC President and a member of Dispute Review Boards.

He is the current joint editor of Keating on Construction Contracts. He produced the 8th Edition and the recent 2009 Supplement. He was a founding editor of Construction Law Journal and continues as a Consultant Editor. He has edited or contributed to or is a member of the editorial board of a number of other publications.

He is also a Special Professor in the Department of Civil Engineering at the University of Nottingham and has recently been appointed as a Visiting Professor at the Centre for Construction Law and Management at King's College, London. In November 2005 he was appointed as a High Court Judge in the Queen's Bench Division and in September 2007 was appointed Judge in Charge of the Technology and Construction Court.

### Wilfred **ABRAHAM** – Zul Rafique & Partners, Malaysia

Wilfred Abraham is head of the Arbitration and Alternative Dispute Resolution Practice Group at Zul Rafique & Partners. Particular area of practice being alternative dispute resolution, with particular emphasis on arbitration. Appears as Counsel and Arbitrator in many arbitrations, including arbitrations conducted under the auspices of the International Chamber of Commerce, the Kuala Lumpur Regional Centre for Arbitration (KLRC) rules and the UNCITRAL rules. Presently, he is on the committee of the Rules for Arbitration of the KLRC and is also on the panel of arbitrators of the KLRC. Has presented and written articles on arbitration and was the co-author of the FIDIC and how it can be used in Malaysia.

### Professor Ian **BAILEY SC** – Wentworth Chambers, Australia

Professor Ian Bailey SC is a barrister specialising in construction disputes. He is a Professorial Fellow of the University of Melbourne Law School and has been involved in the development and conduct of the Construction Law masters program since 1998.

For ten years before 1980 he was a practising architect in Sydney. He was National Vice President of the Institute of Arbitrators and Mediators Australia 2004 to 2008 and is a Grade 1 arbitrator. He has conducted numerous major construction and commercial domestic arbitrations and Court References. He has been the sole appointee in two international arbitrations.

He is the founding Chairman of the Society of Construction Law in Australia.

Author *Construction Law in Australia* (3<sup>rd</sup> Edn late 2010) and Chapter 27.7: Professional Liability, Architects and Engineers in *Laws of Australia*. Co-author with Matthew Bell, of *Understanding Australian Construction Contracts* 2009.

### **CHOW Kok Fong** – Chartered Arbitrator and Chartered Quantity Surveyor, Singapore

Chow Kok Fong is a Chartered Arbitrator and Chartered Quantity Surveyor. At present he practices as a mediator, arbitrator and adjudicator. Since 1990, he has been appointed for more than 160 arbitration, adjudication and mediation references in Asia. He has undertaken management consulting work for multi-lateral agencies such as the World Bank and leading international companies. Until October 2008, he was Chief Executive Officer of Changi Airports International. Earlier he was Chief Executive of the Construction Industry Development Board, now the Building and Construction Authority following which he was Chairman of Guthrie Engineering Pte Ltd, Director of Projects with City Developments and Managing Director for the International Division with the Capitaland Commercial Group. Mr Chow is the founder President of the Society of Project Managers and was Chairman of the Society of Construction Law. Currently, he is also on the board of the Singapore Mediation Centre and Chairman of the Accreditation Committee for Construction Adjudicators. Mr Chow has authored 8 books on construction law, joint ventures and the economics of the construction industry including the *Law and Practice of Construction Contracts* (which had gone into its 3<sup>rd</sup> Edition), *Security of Payments and Construction Adjudication and Construction Contracts Dictionary*.

### John **COCK** – Evans & Peck (Hong Kong) Co. Ltd, Hong Kong

John is an architect, designer and project manager, with experience of commercial, retail and institutional projects in Hong Kong, Australia and South-east Asia. John is experienced in design development, specification, project documentation and coordination, statutory compliance, contract and practice administration, arbitration, dispute resolution and forensic architectural consulting.

A Chartered Arbitrator, Accredited Mediator and Accredited Adjudicator, John acts as third-party neutral, expert witness and party advisor for parties in commercial disputes, particularly those involving architectural or building issues.

John is currently Chairman of the Society of Construction Law Hong Kong and Immediate Past Chairman (2007-9) of the Chartered Institute of Arbitrators (East Asia Branch).
