##### **Dr Chris Vickery**

Dr Vickery has been in architectural practice in Singapore since 1979. His practical experience during this period has fostered his interest in construction law. He is a graduate of the Kings College London/National University of Singapore M.Sc programme in Construction Law and Arbitration. He is a Fellow of the Singapore Institute of Arbitrators and has in recent years served as a council member of the Society of Construction Law, of the Singapore Institute of Arbitrators and of the Singapore Institute of Architects, where he also chairs the Dispute Resolution Sub-committee. He is appointed by the Singapore Mediation Centre as an adjudicator under the Building and Construction Industry Security of Payment Act.

##### **Mr. Anil Changaroath**

Anil is a partner with Aequitas Law LLP and has been in practice since 1995. He represents parties in the region primarily involved in commercial, civil, corporate and criminal litigation and dispute resolution work with a focus on construction, infrastructure and international arbitration work.
